## **Information about processing of personal data in connection with the withdrawal from the Sales Agreement**

Personal data will be processed in order to handle the process of withdrawal from the Sales Agreement under Article 6(1)(c) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) in relation to the provisions of Chapter 4 (right of contract withdrawal) of the Consumer Rights Act of 30 May 2014 (J./L. 2014, Item 827, as amended).

The Form of Withdrawal from the Sales Agreement will be included in the accounting records and will be kept there for the period required by applicable law. In relation to handling the process of withdrawal from the Sales Agreement, data may be processed by third-party entities involved in handling this process, such as express delivery companies, postal operators, banks, hosting providers and accounting office.
